

## Sound Transit's Transit Developer Data Access Terms of Use

This is Sound Transit's Developer Data Access Portal. By accessing schedule, geographic, or any other data posted by Sound Transit ("Data"), you agree to these Terms of Use ("Terms"). Sound Transit may update or modify these Terms at any time.

1. Sound Transit grants you a limited, revocable license to use, reproduce, and redistribute the Data in accordance with these Terms.
2. The Data is collected from various sources and will change over time and without notice.
3. Sound Transit reasonably believes that making this Data available to you is not an infringement or other violation of any intellectual property rights. To the extent copyright in the Data is held by Sound Transit, you are hereby permitted by Sound Transit to copy, store (electronically or otherwise), create derivative works based on and perform and display (publicly or otherwise) such Data, and make such Data available to end users.
4. The Data is provided to you "AS IS" and "AS AVAILABLE" and "WITH ALL FAULTS" basis without any warranty of any kind, express or implied, including without limitation the implied warranties of merchantability, fitness for a particular purpose, accuracy and non-infringement.
5. The Data is not intended to constitute advice nor is it to be used as a substitute for specific advice from a professional. You should not act (or refrain from acting) based upon the Data without independently verifying the Data and, as necessary, obtaining professional advice regarding your particular facts and circumstances.

9. Sound Transit reserves the right at any time and from time to time to modify or discontinue access to the Data (or any part thereof), temporarily or permanently, with or without notice to you. You agree that Sound Transit will not be liable to you for any modification, suspension or discontinuance of access to the Data.

YOU UNDERSTAND AND AGREE THAT IN NO EVENT WILL SOUND TRANSIT BE LIABLE FOR ANY DIRECT OR INDIRECT DAMAGES, EVEN IF BOTH PARTIES ARE AWARE OF THE POSSIBILITY OF SUCH DAMAGES, INCLUDING WITHOUT LIMITATION LOSS OF PROFITS OR FOR ANY OTHER SPECIAL, CONSEQUENTIAL, EXEMPLARY OR INCIDENTAL DAMAGES, HOWEVER CAUSED, WHETHER BASED UPON CONTRACT, NEGLIGENCE, STRICT LIABILITY IN TORT, WARRANTY, OR ANY OTHER LEGAL THEORY, ARISING OUT OF OR RELATED TO YOUR USE OF THE DATA.

12. You agree to indemnify, defend and hold harmless Sound Transit and its officers, directors, and employees from and against all fines, suits, proceedings, claims, causes of action, demands, or liabilities of any kind or of any nature arising out of or in connection with your use of the Data.
13. The exclusive jurisdiction and venue for any dispute, action, or suit of any nature involving the Data and its content, including, but not limited to, actions for injury

to a person or property or infringement of intellectual property rights, shall reside in either the Federal District Court, Western District of Washington or the Superior Court of Washington situated in King County, Washington. The laws of the State of Washington shall govern the interpretation of these Terms and all disputes relating to the Terms or use of Data.

14. These Terms constitute the entire agreement between the parties as to their subject matter, and there are no other conflicting terms, conditions or obligations between the parties relating to the use of the Data. IF YOU DO NOT AGREE TO THESE TERMS, DO NOT ACCESS OR DOWNLOAD THE DATA.
